2. COMPOSITION/INFORMATION ON INGREDIENTS

Product contains only substances permitted under US 21 CFR 178.3570 for use in lubricants with incidental food contact.

Highly refined mineral oils and additives.

3. HAZARDS IDENTIFICATION

Emergency Overview	
Appearance and Odour	: Amber. Liquid. Neutral odour and taste.
Health Hazards	: Not classified as dangerous for supply or conveyance.
Safety Hazards	: Not classified as flammable but will burn.
Environmental Hazards	: Not classified as dangerous for the environment.

Health Hazards : Not expected to be a health hazard when used under normal conditions.

4. FIRST AID MEASURES

7. HANDLING AND STORAGE

- General Precautions** : Use local exhaust ventilation if there is risk of inhalation of vapours, mists or aerosols.
